Little Commercial Street

This parking area is completed with the exception of the lighting, just waiting on AusNet to connect the power supply. The parking is now designed to utilise the flattest part of this area. KBA has worked with the Shire after many concerns were raised by businesses earlier on, when this section was to have no all-day parking and we have achieved a combination of 1 hour & all-day parking. We feel the 1-hour parking is not

ideal and have followed this up with the Shire. The idea behind this is to turn the parking spaces over more often, giving short stay shoppers a greater chance of finding a parking spot. As we have a lot of development still to come in our shopping precinct, it was agreed that these parking restrictions will remain until all works have been completed & the Hub is operating. This will be monitored and can be revisited at that time for the best outcome for everyone concerned.

Upper Commercial Street (area behind Post Office/Kelly's Bakery)

This area is about to begin redevelopment with the contract for the works award last month by the Shire. It was hoped that the development of the whole railway land area, as well as the parking area would be completed at the same time. This has not been possible as there are still several hurdles to jump with heritage issues on the railway land. The Shire has been working through these issues with the various organisations. A decision was made to proceed with the parking which is not affected by the heritage overlays. The design includes parking and walkways from Bridge Street down to the large open shed structure in front of the Railway Station. An upgrade of the roadway that exits onto the highway near T for Tyers is included and two electric car chargers will be installed.

All businesses in this area have had a visit from the contractors and Shire personnel to discuss the works.

No doubt this will cause disruption to anyone using this area and once again we must focus on the end result.

Commercial Street

The upgrade for Commercial Street is scheduled to take place in early 2024. There has been no further development on this at present, but it will be good to have the one lane of traffic each way at a slower speed, giving a safer pull over area to make a parallel park as we have seen near the Mine Road shops.

Radovick/Commercial Street intersection

KBA have been pushing to have this intersection signalled at the time of the Commercial Street upgrade. The idea forms part of the 2016 Streetscape Master Plan although it is a longer-term plan suggested for the future. We feel installing this now and moving the pedestrian crossing to the intersection would give safer access to the highway from the south side of town. Despite our efforts here, we have not been successful in having this completed during the upgrade of Commercial Street. The Department of Transport & Planning are exploring the potential for traffic signals at the intersection and will continue to liaise with Council to progress the matter. The Commercial Street upgrade design will take this into consideration for easier

installation when the time comes.

Power supply underground in Commercial Street

This is another area that we had been pushing for some time but to no avail. It is costly project and the authorities involved do not have an appetite or budget for it. We can only put our best foot forward and are not aways successful.

Bank Senate Enquiry

We have made a submission to the Government Senate Inquiry into bank closures in regional Australia, following on from the submission we made last year to the Regional Banking Taskforce looking at the impacts of bank closures for regional town.

We are very grateful that the Bendigo Bank made the decision to stay in our town as the only bank. We can't stress enough the importance of supporting this bank & are grateful for those that made the change for the sake of our town. Give them a call as the staff are ready and willing to assist.
